Who is an unpaid Carer?




A carer is anyone, including children and adults, who looks after a family member, partner or friend who needs help because of their illness, frailty, disability, a mental health problem or an addiction and cannot cope without their support. The care they give is unpaid. (NHS England)

Who do carers care for?









Carer Need

- Or, 91,469 Carers in total
- 20,875 (or 23%) Carers registered with Birmingham Carer's Hub











Carer Projects Purpose



As part of the Birmingham Carers Hub contract, Forward Carers CIC is commissioned to run a Carer Projects grants scheme that:

- expands provision for unpaid Carers in Birmingham
- integrates with Birmingham Carers Hub
- delivers positive wellbeing outcomes for Birmingham Carers
- offers value for money

The programme is managed by Forward Carers but successful projects will also support Carers to register with Birmingham Carers Hub service, to further improve outcomes for Carers.

Carer Projects Learning



• Building on previous 2019-2022 Grants Programme that funded 13 projects

Independent review carried out by BVSC celebrated the programme for making real impact for Carers in Birmingham and providing new activities/ services and support for new Carers.

- Some recommendations from the review, which we have implemented:
 - Outcome monitoring to be standardised to simplify programme evaluation
 - Avoid overlap of provision to find more hidden Carers and address wider need/gaps
 - Consideration of how grassroot Carer projects can also be supported
 - Work closer with grant holders so beneficiaries get access to wider Carers support via other projects and Carers Hub registration.

Carer Projects Overview (Tranche 1 of 2)



- Looking to fund 10 projects running from September / October 2023 September / October 2025 (12 24 months)
- Project values £10,000 £25,000 max per annum
- Opens 23 June: Online application and eligibility screening, guidance documents provided

Priority Funding Areas



Projects are invited that address the priority areas below:

Support for LGBTQ+ Carers	To increase provision / Carers UK priority
Support to improve Carer mental wellbeing	ICB & Carers UK priority
Support for Young & Sibling Carers (age 14 years +)	Increase young Carer transition
Support for Bereaved / Pre-Bereaved Carers	Joint Commissioning Objective
Support to address Carer Health Inequalities	ICB priority
Other Carer groups not specified	Evidence of need provided by applicant

Eligibility & Success/ Exclusion criteria



- ✓ Non-profits (including CICs/ SEs/Charities/Community groups)
- ✓ Organisations with a reach into unpaid Carers in Birmingham
- ✓ Projects that bring something new, address gaps in support or reach new Carer groups
- ✓ Projects that will create positive wellbeing impact Projects should encourage, develop and maintain a Carers independence, wellbeing, confidence and resilience by using assets within their local communities.
- ✓ Partnership working if it strengthens the project
- ✓ Additional weighting: Something new/innovative; Value for money; Real Living Wage/ staff wellbeing ethos; Track record of delivering a difference to families

- X Duplication of existing services/ activities (unless reaching a group these don't)
- X Funding for core costs (outside of project)/ projects already running
- X Political or religious activities
- X Unconstituted groups, but possible future funding option...

Programme Evaluation





- Carer Projects will need to deliver against 9 Outcomes Domains
- Expectation that Carer projects will make a tangible difference against at least 2 Outcomes

Application: Key Project Questions



- 1. Describe your project/ activity (500 words)
- 2. Who are the beneficiaries? (500)
- 3. What relevant experience do you have to deliver this project? (350)
- 4. How have you / will you continue to involve Carers in project design and delivery?* (350)
- 5. What outputs, outcome and impact will you deliver? (Table format)
- 6. List your key milestones and dates (Table format)
- 7. Provide a budget breakdown (ensure this demonstrates value for money*) (Table format)


Conditions of Funding



- 1. Deliver the project as per described in the grant application (contract and SLA)
- 2. Ensure that relevant data for Carers accessing the project is recorded
- 3. Quarterly project reporting (including activity data, project take-up and Carer case study)
- 4. At least 85% of Carers accessing the service must complete an outcomes-based questionnaire
- 5. Take part in evaluating the programme
- 6. Ensure all Carers are made aware of and supported to register with Birmingham Carers Hub
